Information provided pursuant to articles 13-14 of the GDPR 2016/679 (General Data Protection Regulation)

Dear Sir/Madam,

pursuant to art. 13 of EU Regulation 2016/679 and in relation to the information that will come into our possession, for the purpose of the protection of people and other subjects regarding the processing of personal data, the following information is provided:

1. Purpose of the Data Treatment

The data you provide will be used for only purpose of responding to your requests and information regarding the activities of the CINV and will be processed according to the terms of the law, impartially following the principles of transparency.

2. Processing methods

The ways in which personal data will be processed include the use of electronic tools, your data will be managed only by the administrator of the CINV website in a relevant, adequate, limited and transparent way.

3. Providing data

The provision of data for the purposes referred to point 1 are mandatory to process your application and any refusal of authorization implies the non-acceptance of any request for information. Any data considered inaccurate or useless will not be kept.

4. Communication and dissemination of data

Data provided will be communicated exclusively to the CINV Administrator, Dr. Inf. Massimo Rivolo

The data provided will not be subject to communication or dissemination to any other subject except data related to any training courses that adhere to the law and in the field of continuing education in medicine (ECM), whether you decide to attend a course at CINV. The data will also be kept for a limited period of time to process your information and requests. During this period, the data owner may make an explicit request by writing to the website

5. Data Controller

6. Rights of the interested party

At any time, you can exercise, pursuant to articles 15 to 22 of EU Regulation no. 2016/679, the right to:

- a) request confirmation of the existence of your personal data;
- b) obtain information about the purposes of the processing, the categories of personal data, recipients or categories of recipients to whom the personal data have been or will be communicated and, when possible, the retention period;
- c) obtain the correction and deletion of data;
- d) obtain the limitation of the treatment;
- e) obtain data portability, i.e. receive them from a data controller, in a structured format, commonly used and readable by an automatic device, and transmit them to another unimpeded data controller;
- f) oppose the treatment at any time and also in the case of treatment for the purpose of direct marketing;
- g) oppose an automated decision-making process relating to natural persons, including the profiling. N. B. The CINV website does not perform any user profiling.
- h) ask the data controller for access to personal data and rectification or cancellation of the same or the limitation of the treatment concerning him or to oppose their treatment, in addition to the right to data portability;
- i) withdraw consent at any time without prejudice to the lawfulness of the processing based on the consent given before the revocation;
- j) propose a complaint to a supervisory authority.
